

TOURNAMENT RULES

(*abbreviated – see website for full version)

1. All Federal and State rules and regulations will apply.
2. “Blackjack” means Slot Redfish & Flounder closest to 21” w/o going over, trout will be closest to 19”.
3. Individual Tournament but any number of anglers can fish together.
4. **Guides allowed.**
5. **No Captain’s Meeting** & you can **Launch ANYWHERE you want**
6. Wade fishing is permitted within sight of other team member (200 yard max).
7. All persons on the boat must be entered, no exceptions.
8. Fishing hours will begin at 7:00 AM CST on April 5, 2025 and contestants must be in weigh-in line by 4:00 p.m. **Weigh-in will begin at 2:30 p.m.**
9. **You may not leave a “no-wake zone” until 6:30 AM CST April 5, 2025. ****
10. Weigh-in @ West End Marina (Sea Isle) – **
11. **Artificial or Live Bait**
12. No team is permitted to approach nearer than 50 yards to any other boat, unless permission has been granted.
13. No fish may be accepted from or given to another team or angler on your boat or other boat.
14. No communication between other tournament anglers or outside sources during tournament.
15. Boat, Wade or Kayak fishing is all permitted
16. **Boundaries:** Participants may fish anywhere in West Bay, being any navigable waterway West of the Causeway Rail Bridge to SH 332 bridge.
17. All participants are subject to a polygraph
18. **Anglers must be in the weigh in line no later than 4:00 p.m.**
19. All fish weighed in must be within the regulations of TPWD.
20. In case of a tie, earlier measured fish will determine the winner or weighed if in the side pot.
21. Only approach weigh master with one fish per species per person plus any side pot fish.
22. A “Check-It Stick” is the preferred measuring device
23. A “side pot” redfish can, if desired, be used in both the side pot & blackjack division.
24. All Weigh master’s rulings are FINAL
25. Anglers must be standing in line to hold their position in the weigh line. No exceptions.
26. Sponsors and organizers are not responsible for any accident or injury, nor loss, damage, or theft to any property.
27. **Trophies** will be awarded!
28. **Side Pot: (Optional)** - \$20/ angler Redfish w/ most spots- 60/30%/10% cash payout. **
29. Kayak Anglers – Refer to website for full version
30. Cash Payout (1st – 3rd Place for Trout, Red & Flounder)
31. Awards Ceremony – 5:00 PM

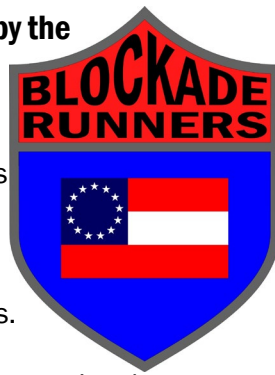

About the Gary J Lynn Foundation

Gary was born with spastic quadriplegic cerebral palsy. After six hours of blood transfusions, the doctors had no hope that he would ever function at a normal level. Under the best of circumstances, his parents were told, the most they could hope for was a child with a severe learning disability. Not wanting to give up on their son, Gary's parents began working with him at home. At two years of age, Gary was enrolled in a school for children with special needs. Within a few weeks he was working on a computer. With constant stimulation and unrelenting guidance, Gary began reading words and short sentences at the age of four. Next came the Pre-K program, elementary school, and Gary's fifth grade graduation where he received the Presidential Award for Outstanding Academic Excellence. Having made the honor roll almost every year in high school, this outstanding young man graduated in 2010 among the top twenty fifth percentile of his class. Gary is now in college with hopes to become a sports attorney and eventually go into politics. He plans to continue The Gary J. Lynn Foundation, supporting research which will benefit all those who are afflicted with cerebral palsy.

Gary refuses to be defined by his disability. He has a wonderful sense of humor and an extremely quick wit.

Cerebral palsy may have confined him to a wheelchair, but his mind and unbridled spirit make him stand 10 feet tall. Those of us who know him are in awe of his ability to confront adversity with amazing grace and are honored to be considered among his friends.
