3rd Annual West Bay Black Jack Tournament & Fundraiser

Rules & Regulations

1. All Federal and State rules and regulations will apply. Violation(s) will result in disqualification.
2. **“Black Jack”** means: Trout, Slot Red and Flounder closest to 21” without going over
3. This is an individual tournament however **any** number of anglers can fish together.
4. Guides are allowed → 21” w/o going over levels the playing field!
5. Wade fishing is permitted; must be within sight of other anglers fishing with you (200 yards max)
6. **Fishing hours** will begin at safe light (Sunrise) on April 28, 2012. Contestants must be in weigh-in line by 5:00 p.m. **Weigh-in will begin at 4:00 p.m.**
7. You may launch anywhere! Anglers are not allowed to leave the dock / ramp / no wake zone until 30 minutes prior to sunrise.
8. **Artificial, live or dead bait may be used.** All fish must be caught on a rod and reel.
9. No angler(s) is permitted to approach nearer than **100** yards to any other boat, unless permission has been granted.
10. No fish may be accepted from or given to another angler(s). Polygraph will be enforced.
11. All anglers on your boat or in your group must be entered in the Tournament.
12. Boat, Wade, Kayak or Beach fishing is all permitted within the stated boundaries.
13. Participants may fish anywhere in West Bay, being any navigable waterway West of the Galveston Rail Road Bridge. Anglers must stay west of the bridge and can venture as far into West Bay as Bastrop, Chocolate Bay / Bayou, Drum Bay and Christmas Bay. Anglers wishing to fish from the surf may fish any beachfront area between the end of the Seawall and San Luis Pass (Galveston side) – Check the forum online for a detailed boundary map.
14. All participants will be subject to polygraph testing.
15. Anglers must be in the weigh in line no later than 5:00 p.m., unless you are standing in line or you are noticed by an official in the parking lot bringing in your fish, weigh in will close immediately at 5 PM.
16. All fish must be within the regulations of TPWD. Any undersized or oversized fish that are turned in for measuring that are not within regulations will disqualify the angler.
17. In case of a tie, the earlier measured fish will prevail.
18. All Weigh master’s rulings are FINAL
19. Each angler will receive a FishWestEnd T-shirt with their entry.
20. Sponsors and organizers are not responsible for any accident or injury, nor loss, damage, or theft to any property.
21. Trophies will be awarded to 1st place in each category. Cash Payout to the top 3 anglers for each species.
22. Side Pot (OPTIONAL): Big Trout (heaviest trout – no live or dead bonus) 100% cash payout
23. **A percentage of every entry fee will be donated to Texana Center for Children.**

Braiden's Story

Braiden is a cute and happy 4 year old with the most marvelous mop of curly brown hair, so what makes him so special? Braiden has autism spectrum disorder.

When Braiden was less than 2 years old, he was consistently delayed in reaching his developmental milestones. At his 2 year old check up his mom mentioned his speech delay to his pediatrician, Even though his pediatrician did not appear concerned during his checkup, the day care provider and his mom felt that Braiden's overall developmental skills were delayed. This was more apparent in his socialization skills when playing with a group of peers he never interacted with them. A co-worker gave mom the telephone number for the Early Childhood Intervention program. His mom began researching speech delays and saw that autism was mentioned on several websites. When she started looking down the list for signs of autism, she recognized several red flags; the tip toeing, hand flapping, and lack of communication skills.

In April 2011, Braiden was admitted into Texana Children's Center for Autism. At that time he could speak in three word sentences but lacked developmental appropriate language skills, wore diapers and engaged in aggressive behaviors. Within a month of applied behavior analysis treatment, he was toilet trained, his speech had improved, along with his socialization skills. Within six months he learned his letters, numbers, colors, shapes and is even reading. He has friends at both school and church; where previously his parents were hesitant to take him because of his behavior. Today he is excited to go to church and to school: he makes great eye contact, participates in activities and follows directions.

Braiden's progress has been remarkable; he has joined the Texana Bridge Class where he is exposed to typically developing peers in a regular pre-school setting. His mom says *"The dreams I had for him once were gone, and now they are back, I feel the sky is the limit for Braiden- I got my child back"*
