Tournament Information

Welcome to the Manvel Lions Club Annual 24 Hour Salt Water Fishing Tournament. Seating will be limited, so please bring your own. Food and soft drinks will be provided for contestants at the Weigh-In. Alcoholic beverages will not be permitted. Tournament entry will be limited, so please get your entry in as early as possible. Last minute substitutions are allowed as long as the replacement entry signs the Team Entry Form and pays the late entry fee.

Check-In/Weigh-In

Check-In and Weigh-In will be in the parking lot at the Bass Pro Shops located at Hwy. 288 and Beltway 8. Check-In will be at 3:00pm on Friday, May 13th and at least one team member will be required to check in. No weigh-in will be done on Friday. Weigh-In will begin on Saturday, May 14th at noon and run until 3:00pm. All contestants must be in line at the Weigh-In by no later than 3:00pm or be disqualified.

All winners will be announced after Weigh-In is tallied-up on Saturday May 14th. Overall heaviest 3 stringers for each category for the entire tournament will be paid.

Each Stringer of fish will consist of 5 Fish.

Official Rules

1. All Local, State, Coast Guard, and Parks and Wildlife regulations and laws shall apply during the tournament.
2. The entry fee must be paid by deadline to qualify for door prizes and/or prizes.
3. All contestants, by their entry signature, grant to the Manvel Lions Club, unconditional release from any and all liability for personal injury, death, damage, lost or stolen property or accidents. Each contestant is solely responsible for his/her actions with regard to inclement weather or other dangerous situations. Contestants assume the risks of any and all damages or injury of any nature which may result from any source whatsoever during the tournament. It would be wise to carry a portable radio to stay abreast of any weather changes.
4. All decisions by the Tournament Committee are final.
5. Pooling or transferring of fish is not permitted.
6. Only fish caught during the tournament times are eligible.
7. Tournament will be with rod and reel or cane pole only. No drop lines allowed.
8. Any contestant found in violation of any tournament rules will be subject to disqualification.
9. All persons in a party must be registered in order for anyone in that party to qualify for prizes.
10. The tournament area consists of the Galveston Bay system. Type of fishing permitted is boat, surf, wade, or pier.
11. A valid Fishing License is required to receive prize money, unless contestant is under 16 years of age.
12. No Fishing Guides Allowed.
13. No refunds.
14. All weighed fish must be in edible condition. No tackle attached to fish.
15. All winners could be subject to a polygraph examination before receiving any money. Youth (under 16 years of age) who win could have their parents/guardian who was with the youth could be required to take the polygraph examination.
16. No culling of fish at tournament scale. All fish weighed will be part of stringer.
17. Any team trying to weigh-in illegal fish will be disqualified from the entire tournament. This will include more than 1-oversized trout per team member. Door Prizes also.
